ORDINANCE 06-08

An ordinance Amending chapter 12.20.015 Deposit to establish a process for Setting and Amending Electricity Deposits

BE IT ENACTED By the City Council of the City of King Cove:

- Section 1. Classification. This is a Code Ordinance.
- Section 2. Effective Date. This Ordinance becomes effective Immediately upon adoption at second reading.
- Section 3. Content. Chapter 12.20.015 of the City of King Cove Code of Ordinances, is hereby amended.


12.20.015 currently reads as follows:


**12.20.015 Deposit.** With each application there shall be a deposit of five dollars (\$5.00) for residential property and twenty-five dollars (\$25.00), or such amounts as may be determined necessary, for business or commercial property, to guarantee the payment of all bills. When the service to any consumer is permanently discontinued, this deposit, less the amount of any unpaid bill, shall be returned without interest. (Ord. 77-01 part), 1977)

As Amended, 12.20.015 shall read as follows:

**12.20.015 Deposit.** With each application there shall be a deposit of one hundred and twenty five dollars (\$125.00) for residential property and two hundred and fifty dollars (\$250.00), or such amounts as may be determined necessary, for business or commercial property, excluding harbor vessels, to guarantee the payment of all bills. When the service to any consumer is permanently discontinued, this deposit, lest the amount of any unpaid bill, shall be returned without interes.
